Individual Equity Membership

Individual equity memberships are available for a one-time buy in rate of **\$600**. The annual maintenance fee for **FY 2025-2026 is \$1175** and will be prorated for an applicant joining after the start of the fiscal year (September 1). Individual equity members have full voting rights, may hold office in the Club, and any unmarried or dependent children, under 23 years of age, living at home, are eligible to play under this membership. Equity members are eligible to pay a reduced annual maintenance fee should they qualify each fiscal year for a “Leave of Absence” of at least three consecutive calendar months during the period September 1 to May 31 and notify the treasurer of such intention prior to September 1 of the calendar year. Those applying after September 1 will receive a dues credit for the following year. The “Leave of Absence” annual maintenance fee for **FY 2025-2026 is \$900**. Upon approval of membership by the Board of Directors, applicants will be notified and billed.

One-Year Associate Membership: \$1450

Play tennis at NTC from September 1 thru August 31, renewable annually from start of fiscal year (September 1). First time members only are pro-rated if joining after the start of the fiscal year. Fee is all-inclusive.

Introductory Associate Membership: \$625

One-time non-renewable 6-month introductory trial membership for first time prospective members. All-inclusive fee. You may convert thereafter to equity membership or one-year associate. The 6 months may be split, upon request.

Spring/Summer Membership: \$425

Seasonal residents who wish to have access to indoor facilities in the spring/summer months may apply for spring/summer associate membership and play from April 1 – August 31

Summer Associate Membership: \$340

Seasonal residents who wish to have access to indoor facilities in the summer months may apply as summer associates and play from May 15 to September 15.

For all associate categories, there is no annual maintenance fee and no hourly court fee. Associates have no voting rights and may not hold office in the Club.
